Property Taxes:

The municipal tax portion remains the same as last year, with an average tax increase of 0%.

After a freeze in 2024-25, Provincial education property tax rates will increase in 2025-26 to support Alberta's schools. This results in a 10.77% increase for Sundance Beach residents.

Public works

A new sidewalk will be built on the west side of the John Turgeon Community Hall to increase safety. The site is currently steeply sloped and can be slippery.

All public works equipment is now electric. The old gas-powered equipment will be sold, and the new equipment was purchased using grant funding.

Filling in low spots on Vine Avenue near cottages #60 to #65 and cottages #33 and #34.

The culvert near 1st street may be repaired.

A shade feature will be added to the picnic table at the playground.

Pickleball Committee:

The Summer Village is considering a new pickleball court near the parking lot of the John Turgeon Hall. Summer Village Council will consider recommendations from the Pickleball Committee.

Currently when the hall is booked, the parking lot pickleball court is closed.

Funding for a new court would come from provincial grants.

Data is being collected to determine usage of a potential court. Please contact our office with the number of players in your family.

Additionally, there will be a usage tracking sheet on the shed near the parking lot court. Help us keep track of how often the current court is used, or if you want to play and the court is unavailable.

Land Use Bylaw:

Distinguished Service Award

Alberta Municipalities has honoured Mayor Brian Waterhouse with a Distinguished Service Award.

The award was presented during the conference on September 24, 2024 in Red Deer.
